**Remote Learning Offer**  
**2020- 2021**



Our Remote Learning offer is for pupils who have to self-isolate, or where local or national restrictions mean that pupils need to stay at home.

Our Remote Learning offer has been made with our pupils and their families in mind. We believe that this strategy will work best for the pupils at our school.

Our Remote Learning offer should ensure that deprivation barriers are removed so all children have the same learning experience from home and access to technology.



## The Aims of our Remote Learning Offer

Ensure provision is in place so that all pupils have access to high quality learning resources.

Protect pupils from the risks associated with using devices connected to the internet.

Minimise the disruption to pupils' education and the delivery of the curriculum

Ensure staff, parent, and pupil data remains secure and is not lost or misused.

Ensure robust safeguarding measures continue to be in effect during the period of remote learning.

Ensure all pupils have the provision they need to complete their work to the best of their ability, and to remain happy, healthy, and supported during periods of remote learning.

Ensure continuity of learning between home and school including during periods of lockdown and pupil absence.



## What our Remote Learning will look like

**What should my child expect from immediate remote education in the first day or two of pupils being sent home?**

In the first day or two of a child being at home they will be provided with the overview timetable for the class with links to Teams sessions and sheets that can be downloaded and printed or school will provide printed copies of sheets where required

**Following the first few days of remote education, will my child be taught broadly the same curriculum as they would if they were in school?**

We teach the same curriculum remotely as we do in school wherever possible and where it is appropriate.



### What will our Remote Learning Timetable look like ?

We expect that remote education (including remote teaching and independent work) will take pupils on average the following number of hours each day:

EYFS Nursery	1/ 1.5 hours per day
EYFS Reception	3 hours per day
Key Stage 1	3 hours per day
Key Stage 2	4 hours per day

### How will my child access the online remote education that you are offering ?

Across the school from Nursery to Year 6 we use Microsoft Teams as a platform to provide a high quality of education to both pupils in school and those at home.



**If my child does not have digital or online access at home, how will you support them to access remote education?**

We recognise that some pupils may not have suitable online access at home.

We will take the following approaches to support those pupils to access remote education:

Where possible we will lend laptops to pupils who do not have a digital device at home.

We have 20 laptops provided by the DfE and have purchased 40 tablets to support pupils.

We have already identified these families within school and will be in contact as soon as possible

We will also provide paper resources and stationery where needed.

**How will my child be taught remotely?**

We believe in a balanced approach in delivering the curriculum remotely. This will ensure all children have the possibility to succeed and thrive through remote learning.

We will be delivering daily live lessons via Teams as well as using DfE Oak National Academy lesson resources.



## **Engagement and feedback**

Teaching staff will check pupils work and provide feedback to enable pupils to move forward with their learning.

Communication and dialogue between home and school will be encouraged via email and Teams.

A register of engagement of class pupils will be kept by all teachers and any dialogue and responses made with families including the completion of work will be recorded.

Those pupils who do not respond or engage within remote learning will be contacted by class teacher in the first instance.

Safeguarding calls will be made to families who do not engage online.



How will you work with me to help my child who needs additional support from adults at home to access remote education?

We recognise that some pupils with special educational needs and disabilities (SEND), may not be able to access remote education without support from adults at home.

We acknowledge the difficulties this may place on families and we will work with parents and carers to support these pupils.
